- Positive results cannot be guaranteed. Exclusively Equine Veterinary Service can accept no responsibility for the quality of semen, or its disease or genetic status.
- The mare will be kept in the facilities as seen by the owner or owner's agent who has had the opportunity to assess these facilities as a safe environment for the mare.
- Mares will be placed in a crush and examined internally, causing a small but definite risk of injury, infertility or death.
- Reproductive hormones, sedatives and relaxants will be used at the veterinarian's discretion and at the owner's expense.
- In the event of mishap or illness the veterinary staff will attempt to contact the owner immediately. If the owner cannot be contacted with regard to the treatment options then the vet will perform whatever treatment is deemed necessary at the expense of the owner.
